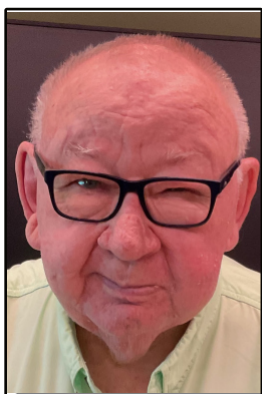

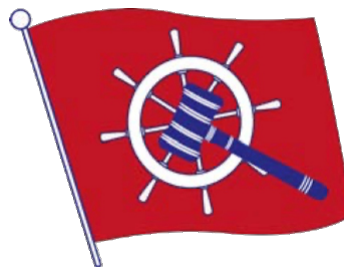

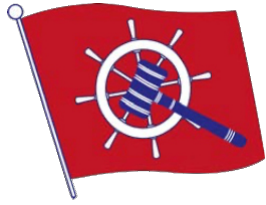

**2025 – 2026 IOBG Job Descriptions
Taken From the IOBG ByLaws and the Policy and Procedures Manual**

**ARTICLE VI (ByLaws)
Officers**

President : The duties of the President shall be to administer the affairs of the organization and preside over all regular meetings thereof and to appoint committees as are necessary for the functioning of the organization. The President shall have the authority to authorize expenditures for amounts exceeding the approved budget for unforeseeable items to an amount not exceeding one thousand five hundred dollars (\$1,500). Any expenditure exceeding the one thousand five hundred dollars (\$1,500) limit must be approved by the Board of Directors, or by the Executive Committee acting in their stead.

The President shall appoint a Recording Secretary, a Legal Officer, and other Officers the President may from time to time deem appropriate. Said appointed Officers, however, need not be members of the Board of Directors, and if not, then shall not be entitled to vote with the Board of Directors and other elected Officers.

President Elect: The duties of the President Elect shall be to assist the President, and, in his or her absence, to act in his or her place and stead, and shall automatically become President upon the expiration of the current President's term. The First or Second Vice President shall act in the absence of the President or the President Elect, and will at all times assist the President in his or her duties

(a) The President Elect shall present a budget for approval at the Annual Meeting for the ensuing year. The budget shall detail as practicable and shall include with other major items, limits for authorized travel expenses.

Executive Secretary: The Executive Secretary shall keep all pertinent records of the organization and will prepare Chapter, District, and Auxiliary Chapters approved by the Board of Directors and keep records of each.

Treasurer: The Treasurer shall receive all monies which may accrue to the organization and shall be responsible for the disbursement thereof, and shall keep complete financial and membership records of the organization and prepare any organization documents required for tax purposes. Subject to the approval of the President Elect, the Finance Committee shall present to the Board of Directors, a budget for the ensuing year.

Recording Secretary: The Recording Secretary shall record and transcribe the minutes of meetings.

From the Policy and Procedures Manual:

The First and Second Vice Presidents report to the President Elect as well as to the President.

The First Vice President shall be responsible for assisting the President and for the Bylaws, Policy Manual, newsletter (The Blue Gavel Log), and Area Vice Presidents east of the Mississippi River and the Director of District 50. The First Vice President reports to both the President and the President Elect

The Second Vice President shall be responsible for assisting the President and for public relations, the IOBG brochure, Area Vice Presidents west of the Mississippi River and the Director of District 51. The Second Vice President reports to both the President and the President Elect.

The designation and duties of Area Vice Presidents are delineated in the IOBG Policy and Procedures Manual under Elected Officers.

Area Vice President: The Area Vice Presidents serve as the primary liaison between the Executive Committee and the Districts assigned.

They shall assist the Districts in implementing directives from the Board of Directors and the Executive Committee, in the promotion of membership growth and public relations, and in effecting and enhancing the liaison between Districts.

Area Vice Presidents are charged with staying abreast of activities within their areas, ensuring that the District Directors are reporting to them, and to report progress made, problems encountered, new ideas generated by the Districts, and with reporting to the First or Second Vice President as assigned.

The Area Vice Presidents should make every effort to visit each of the Districts assigned at least once a year. The Area Vice Presidents are invited to attend and audit the IOBG Executive Committee monthly Zoom or conference call.

They do not have a vote on the Executive Committee but rather are present at the meetings to gather IOBG information to share with their Districts.

Executive Committee: The Executive Committee shall be comprised of the Immediate Past International President, the President, who shall act as Chairman, the President Elect, the First Vice President, the Second Vice President, the Executive Secretary and the Treasurer, whose duties shall include, but not limited to, the following:

- (a) Acting in lieu of the Board of Directors between Annual Meetings;
- (b) Making appointments to fill vacancies;
- (c) Approving the Annual Meeting Committee Report and other Committee reports;
- (d) Reviewing and ruling on Chapter Applications not meeting IOBG Requirements;
- (e) Approving expenditures exceeding the budget;
- (f) Reviewing applications for Auxiliary groups;
- (g) Researching and preparing subjects to be brought before the Annual Meeting. All actions by the Executive Committee shall be by majority vote either in meeting assembled or by proxy. All actions by the Executive Committee are subject to review by the Board of Directors at its next regularly scheduled meeting and must be ratified either in meeting assembled or polled by mail ballot.

I hope this detail information regarding the IOBG leadership will serve you well and bring you a little closer to understanding our association of Past Commodores. Best wishes on a successful year in IOBG.

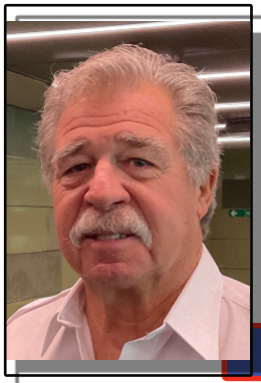

2025 Local Area Program Grants

There were 107 participants coming from 6 states, in the 3-day clinic, both classroom and on the water ending with the Jr. Olympics Regatta. The Regatta has 78 boats racing i Santa Margarita Yacht Club

Pacific Corinthian Youth Foundation - 2025 Summer Sailing Program

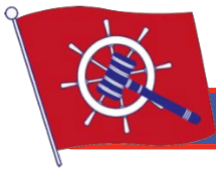

The Pacific Corinthian Youth Foundation is a non-profit organization that sponsors and instructs youth sailing in Channel Islands Harbor. The Foundation was started in 1992 by members of the Pacific Corinthian Yacht Club and uses part of the PCYC grounds and guest docks to run the programs. We want your children to learn to sail and have a great time while they do it. Learning basic sailing skills is supplemented with fun activities such as sailing to the park, having picnics, going on treasure hunts, sailing on bigger boats, playing sponge tag and making sails.

From Beginner through Advanced Sailing and from Optis, and Sabots to Lasers and CFJs, our courses are designed to produce great, young sailors by teaching the fundamentals of sailing, promoting good seamanship, and learning to do it safely.

The Foundation serves all of Channel Islands Harbor and its surrounding communities. The Foundation's Board of Directors is comprised of representatives from Pacific Corinthian Yacht Club, Channel Islands Yacht Club, Channel Islands Women's Sailing Association, with support from Anacapa Yacht Club, which hosts Thursday night races and post-race barbecues. Greetings from District 27 – the great Chesapeake Bay! While we have a small IOBG footprint on the bay, we certainly have a great sisterhood of yacht clubs that support each other. One wonderful yacht-club-wide event is the annual Wounded Warriors Day on the Bay – next one is August 15, 2026. Started in 2012 by North Point Yacht Club's Commodore Jim Diven, he wanted to give back to wounded warriors and veterans, and his vision became Wounded Warriors Day on the Bay. Commodore Jim started with just a handful of boats and captains from his yacht club. They paired up veteran's families with boats and after a crab and shrimp feast put on by North Point YC volunteers, captains and families embarked on a boat ride headed to the Baltimore harbor and back.

Over the ensuing years the event grew tremendously. Because of the growth, the event outgrew North Point YC and shifted to Maryland Yacht Club directly across the river. From a start of 12 boats, MYC now hosts upwards of 70 boats. Boats and captains must be members of a local yacht club. The great thing about that is most captains know each other from attending sister club events. This all ties into Maryland YC, which is one of two active IOBG chapters on Chesapeake Bay and is proud to host this event. The other local IOBG chapter is National Potomac Yacht Club.

Today, the event hosts 300 visitors, families, veterans, Gold Star Mothers, and volunteers that share the day on the MYC campus. To accommodate the 65-70 veteran families, the local yacht club community steps up to provide upwards of 70 boats and captains for the event. As a matter of fact, virtually all of the volunteer boats and captains come in on Friday before the day of the event. That Friday night turned into a Captain's Reception complete with food, beverage, and a live band.



The event day starts with exhibits such as classic cars, Clydesdales, veteran organization exhibits, Baltimore Ravens cheerleaders and mascot Poe, and the Maryland 9/11 Rolling Memorial. The ceremony starts with the presentation of colors by a Vietnam veterans Honor Guard – the same Honor Guard that presents colors to midfield at Ravens games. The ceremony includes an introduction of every veteran by name as they walk the greeting line of captains giving out high fives. At the front of the tent each veteran receives a handshake from a local high-ranking officer, a plaque, and an event military coin.



From there, the entire crowd shifts down the hill to our marina area where the local restaurant chain Mission BBQ feeds everyone lunch. Right after lunch, the captains round up their veteran families and head out for the two-hour boat ride. Waiting back at the yacht club after the boat ride is a full crab feast and cookout for all the guests.

The day also has things for kids. Face painting, moon bounces, backpacks stuffed with donated trinkets, and messing around with Poe and the Clydesdales. There are door prizes and give-aways for everyone. But alas, the day comes to an end precisely at 4:00 as one of our captains finishes the day by playing taps.

A well-oiled team of volunteers that have been running the program for years are what

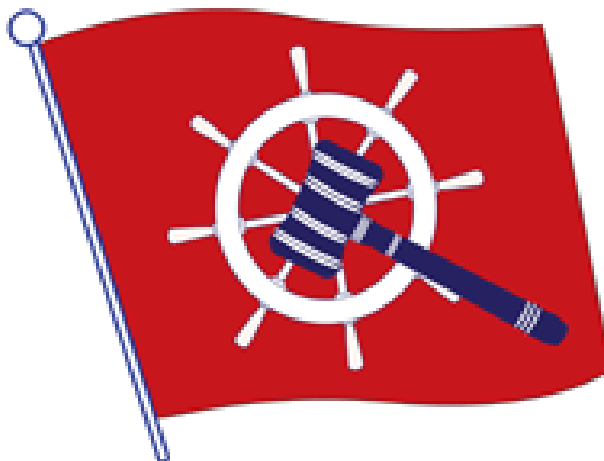


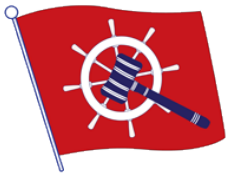
